1. Performance Work Statement

FAS Dar es Salaam seeks to hire a contractor to conduct a hotel, restaurant, and institutional (HRI) market promotion in partnership with one hotel chain in Zanzibar to showcase U.S. ingredients. The selected hotel chain will hold a cooking demonstration using U.S. food products and ingredients. The HRI promotion will create awareness and visibility of U.S. food products in the market, expand sales, and create excitement for U.S. products in advance of the USDA Agricultural Trade Mission to Zanzibar.

2. Definitions.

“CO”: Contracting Officer

“FAS”: Foreign Agricultural Service

“USDA” means United States Department of Agriculture

3. Introduction

The tourism sector is the backbone of Zanzibar’s economy, contributing 27% to GDP and 80% to foreign exchange reserves. The sector accounts for 22,000 direct and 48,400 indirect jobs. Visitors have grown dramatically over time, from 18,000 in 1985 to 538,264 in 2019. While the COVID-19 pandemic adversely affected Zanzibar’s tourism sector, causing a 51% decline in visitors in 2020, tourism investors are optimistic about prospects post-COVID and the number of hotels in Zanzibar continues to grow steadily. In the past five years, there has been a 37% increase in hotel and hostel facilities on the island.

Zanzibar imported \$59 million in fresh and processed food products in 2020. While U.S. exports are strong for certain products (particularly frozen chicken), the U.S. accounts for less than \$1 million of Zanzibar imports. This activity will help boost awareness of U.S. products in the Zanzibar HRI sector, helping to increase U.S. market share.

FAS Dar es Salaam seeks to hire a contractor to work with one or two of the largest hotels in Zanzibar to demonstrate how to use U.S. ingredients to make high-quality meals. These demonstrations may include celebrity chefs or other influencers to boost audience participation. U.S. wines and distilled spirits will be included in the events, when appropriate. The demonstrations will be broadcast over television and social media platforms.

4. Proposed Activities

FAS Dar es Salaam seeks to hire a contractor to work with a top hotel or restaurant in Zanzibar to demonstrate how to use U.S. ingredients available in the market to make high-quality meals. These demonstrations should include a celebrity chef or other influencers to boost audience participation. U.S. wines and distilled spirits will be included, when appropriate. The demonstration will be broadcast over television and social media platforms.

5. Tasks/Deliverables

Embassy Nairobi will notify the CONTRACTOR in writing of any performance deficiencies within 24 hours of the observation. The CONTRACTOR is obligated to respond to such notifications in writing within 24 hours and provide a proposed remedial action. In the event of any repeated deficiency, the CONTRACTOR must provide the response and remediation proposal. The CONTRACTOR, not Embassy Nairobi, is responsible for project management and quality control to ensure the terms of the contract and the intent of the project proposal (attached) are sufficiently achieved. Embassy Nairobi's role is to monitor project quality and ensure that the CONTRACTOR achieves the project proposal objectives.

Payment will be made after the completion of the contract. - (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Reasonable inquiry has the meaning provided in the clause [52.204-25](#), Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. (1) A citizen or resident of the United States;

(2) A domestic partnership;

(3) A domestic corporation;

(4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and

(5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). (f) If the Offeror selects “is” in paragraph (d)(1) and “partial or no exemption” in paragraph (d)(2) of this provision, the Offeror will be subject to withholding in accordance with the clause at FAR 52.229-12, Tax on Certain Foreign Procurements, in any resulting contract.

(g) A taxpayer may, for a fee, seek advice from the Internal Revenue Service (IRS) as to the proper tax treatment of a transaction. This is called a private letter ruling. Also, the IRS may publish a revenue ruling, which is an official interpretation by the IRS of the Internal Revenue Code, related statutes, tax treaties, and regulations. A revenue ruling is the conclusion of the IRS on how the law is applied to a specific set of facts. **For questions relating to the interpretation of the IRS regulations go to <https://www.irs.gov/help/tax-law-questions>.**
