## 2. PREQUALIFICATION INSTRUCTIONS

#### 2.0 Introduction

Wildlife Clubs of Kenya (WCK) invites interested candidates who must qualify by meeting the set criteria as provided by the Procuring Entity to supply and deliver goods, works and services to the organisation.

#### 2.1 Project Objective

The main objective of this part is to pre-qualify for construction, supply and delivery of goods and provide services under relevant tender(s) to Wildlife Clubs of Kenya as and when required during the financial period 2025-2027.

#### 2.2 Invitation of Prequalification

Suppliers registered with Registrar of Companies under the Laws of Kenya in respective merchandise or services are invited to submit their prequalification documents to the National Coordinator, Wildlife Clubs of Kenya so that they may be considered for prequalification for submission of tenders. Applications will be submitted, singly as per category. Wildlife Clubs of Kenya requires prospective contractors/suppliers to submit the mandatory information for pre-qualification.

#### 2.3 Experience

Prospective contractors and suppliers must have carried out successfully supply and delivery of similar item(s)/services to organisations/institutions of similar size. Potential contractors/suppliers must demonstrate the willingness and commitment to meet the prequalification criteria.

#### 2.4 Pre-Qualification Document

This document includes questionnaire forms and documents required of prospective suppliers. To be considered for pre-qualification, prospective contractors and suppliers must submit all the information herein requested and as per Public Procurement and Disposal Regulations Section 23(1) & (2), 24(1) (2) and (3) (a-e).

The Organization reserves the right to request submission of additional information from prospective bidders.

#### 2.8 Invitation to Tenders/Ouotations

Bidding documents will be made available only to those bidders whose qualifications are accepted by Wildlife Clubs of Kenya after scoring more than **70 points**, soon after the completion of the pre- qualification process.

#### 3. BRIEF CONTRACT REGULATIONS/GUIDELINES

#### 3.1 Taxes on imported materials

The supplier will have to pay custom duty and VAT as applicable for all imported materials to be supplied unless the item(s) is/are donor funded.

#### 3.2 Custom Clearance

The contractors shall be responsible for custom clearance of their imported goods and materials

#### 3.3 Contract Price

The contract shall be of unit price type or cumulative of computed unit price and quantities required. Quantities may increase or decrease as determined by demand and on the authority of the client's accounting officer or tender.

#### 3.4 Payments

All local purchase shall be on credit of a minimum of thirty (30) days or as may be stipulated in the agreement.

# 4. PRE-QUALIFICATION DATA INSTRUCTIONS

#### 4.1 Pre-qualification data forms

The attached questionnaire forms PQ-1, PQ-2, PQ-3, PQ-4, PQ-5, PQ-6, PQ-7, PQ-8, are to be completed by prospective suppliers/contractors who wish to be pre-qualified for submission

The pre-qualified application forms which are **NOT filled out completely and submitted** in the prescribed manner will not be considered. All the documents that form part of the proposal must be written in English and in ink.

#### 4.2 Qualification

It is understood and agreed that the pre-qualification data on prospective bidders is to be used by Wildlife Clubs of Kenya in determining, according to its sole judgment and discretion, the qualifications of prospective bidders to perform in respect to the tender category as described by the Client.

Prospective bidders will not be considered qualified unless in the judgment of Wildlife Clubs of Kenya, they posses' capability, experience, qualified personnel available and suitability of equipment and net current assets or working capital sufficient to satisfactorily execute the contract for goods/services.

#### 4.3 Essential Criteria for Pre-qualification

- a) Experience: Prospective bidders shall have at least 5 years' experience in the supply of goods, works, services and allied items in case of potential supplier/contractor should show competence, willingness and capacity to service the contract.
- b) Prospective candidates require special experience and capability to organize supply and delivery of items, or services at short notice.

#### c) **Personnel**

The names and pertinent information and CVs of the key personnel for individual or group to execute the contract must be indicated in form PQ-3.

#### d) Financial Condition

The Candidate's financial status will be determined by the last 3 years financial statements submitted with the prequalification documents as well as letters of reference from their bankers regarding supplier's/contractors' credit position. Potential suppliers/contractors will be pre- qualified on the satisfactory information given.

e) Special consideration will be given to the financial resources available as working capital, taking into account the number of uncompleted orders on contract and now in progress. Data to be filled/provided on Form PQ-4. However, potential bidders should provide evidence of financial capability to execute the contract.

#### f) Past Performance

Past performance will be given due consideration in pre-qualifying bidders. Letter of reference from past customers should be included in Form PQ-6

#### 4.4 Statement

Applicants must include a sworn statement Form PQ-8 by the Tenderer ensuring the accuracy of the information given.

#### 4.5 Withdrawal of Prequalification

Should a condition arise between the time the firm is pre-qualified to bid and the bid opening date which in the opinion of the Client could substantially change the performance and qualification of the bidder or his ability to perform such as but not limited to bankruptcy, change in ownership or new commitments, the organisation reserves the right to reject the tender from such a bidder even though he was initially prequalified.

**4.6** The firm must have a fixed Business Premises and must be registered in Kenya, with certificate of Registration, Incorporation/Memorandum and Articles of Association, copies of which must be attached.

The firm must show proof that it has paid all its statutory obligations and have current Tax Compliance Certificate
