Suppliers who are currently in our list and wish to be considered should apply.

Any canvassing in whatever way will render the prospective bidder(s)/applicant(s) ineligible for participation. The Organization reserves the right to accept or reject any application/tender in whole or in part without giving reason(s) for its decision.

## PRE-QUALIFICATION DATA INSTRUCTIONS

## 1.1 Pre-qualification data forms

The attached questionnaire forms PQ-1, PQ-2, PQ-3, PQ-4, are to be completed by prospective suppliers/contractors who wish to be pre-qualified for submission

The pre-qualified application forms which are **NOT filled out completely and submitted in the prescribed manner will not be considered.** All the documents that form part of the proposal must be written in English.

It is understood and agreed that the pre-qualification data on prospective bidders is to be used by kilimo trust in determining, according to its sole judgment and discretion, the qualifications of prospective bidders to perform in respect to the tender category as described by the Client.

Prospective bidders will not be considered qualified unless in the judgment of Kilimo trust, they posses' capability, experience, suitability of equipment to satisfactorily execute the contract for goods/services.

## 1.2 Essential Criteria for Pre-qualification

a) Experience: Prospective bidders shall have at least 3 years' experience in the supply of goods, works, services and allied items in case of potential supplier/contractor should show competence, willingness and capacity to service the contract.

Prospective candidates require special experience and capability to organize supply and delivery of items, or services at short notice.

b) Past Performance

Past performance will be given due consideration in pre-qualifying bidders. Letter of reference from past customers should be included in Form PQ-3

#### 1.3 Statement

Applicants must include a sworn statement Form PQ-4 by the Tenderer ensuring the accuracy of the information given.

## 1.4 Withdrawal of Prequalification

Should a condition arise between the time the firm is pre-qualified to bid and the bid opening date which in the opinion of the Client could substantially change the performance and qualification of the bidder or his ability to perform such as but not limited to bankruptcy, change in ownership or new commitments, the organisation reserves the right to reject the tender from such a bidder even though he was initially prequalified.

**1.5** The firm must have a fixed Business Premises and must be registered in Kenya, with certificate of Registration, Incorporation/Memorandum and Articles of Association, copies of which must be attached.

**Mandatory** - Copy of current business license and Registration (by registrar of companies) in fields applied for the firm must show proof that it has paid all its statutory obligations and have current Tax Compliance Certificate
